4.2 Quality and importance

En este espacio se encuentra dos taxones del Anexo I de la Directiva aves, Falco naumanni y Ciconia ciconia, en concentraciones importantes de reproducción. Además aparecen varios migrantes de llegada regular como Apus apus, Apus pallidus, Delichon urbica y Hirundo rustica. Toda esta fauna ornítica encuentra su alimentación en la gran cantidad de invertebrados presentes en la vecina ZEPA Llanos de Trujillo.
